I completed coursework which included class discussions based on assigned readings, videotaped examples of cognitive-behavioural therapy (CBT), role-playing, and skill-building assignments. This training provided a comprehensive and practical overview of CBT principles, assessment strategies, case presentation and conceptualization, treatment techniques, and outcome evaluation. Under the supervision of a licensed clinical psychologist, I applied CBT interventions to treat multiple adult clients with a variety of presenting problems including anxiety, depression, interpersonal issues, body-image insecurities, low self-esteem, and suicidal ideation. I was responsible for completing weekly process notes, as well as attending weekly individual and group supervision meetings.

I incorporated information obtained through conducting clinical interviews, questionnaires, and clinical observations to produce behavioral case formulations. I designed appropriate CBT treatment plans based on review of the CBT treatment literature, as well as individualization of standard treatment protocols to the clients and the specific treatment goals. I modified the treatment plans as necessary based on the clients' ongoing responses to the interventions. I demonstrated competencies essential to the therapist role (i.e., establishing rapport, responding empathically, communicating clearly and directly, educating clients to the therapy, engaging clients in an active collaborative relationship, introducing appropriate CBT interventions, teaching and reinforcing skills, problem solving difficulties in the therapy relationship, and addressing issues around termination and relapse prevention). I systematically monitored treatment progress and assessed treatment outcomes incorporating clinical observations, client feedback, questionnaire data, and supervisory feedback. Additionally, I kept timely, concise, and accurate client records as required by the clinic and the course instructor.
